

# **Release Waiver Agreement**

This Release Waiver Agreement ("Agreement") is entered into between Skool U! LLC ("Skool U!"), and the undersigned participant ("Participant") and participant's family.

# 1. Agreement to Waive Claims

In consideration of being permitted to participate in training sessions, clinics, camps, or any other activities provided by Skool U!, the Participant and Participant's family agree to waive any and all claims, known or unknown, against Skool U! LLC, its partners, affiliates, directors, officers, trustees, employees, agents, volunteers, contractors, successors, and assigns (collectively referred to as "Released Parties"), arising out of or in connection with the Participant's participation in said activities.

### 2. Assumption of Risk

The Participant and Participant's family acknowledge and understand that participation in training sessions, clinics, camps, or any other activities provided by Skool U! LLC carries with it the potential for certain risks, including but not limited to, the risk of bodily injury, illness, or other medical conditions. The Participant and Participant's family voluntarily assume all such risks and agree that Skool U! LLC shall not be liable for any injuries, damages, or losses that may occur as a result of such risks.

#### 3. Release of Liability

The Participant and Participant's family hereby release, discharge, and covenant not to sue the Released Parties from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, illness, or other harm that may be sustained by the Participant during or as a result of participation in activities provided by Skool U! LLC.

# 4. Use of Video and Photo

The Participant and Participant's family hereby grant Skool U! LLC and its affiliates the irrevocable and unrestricted right to use and publish photographs and videos of the Participant, or in which the Participant may be included, for editorial, trade, advertising, and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The Participant and Participant's family hereby release Skool U! LLC and its affiliates from all claims and liability relating to said photographs and videos.

## 5. Indemnification

The Participant and Participant's family agree to indemnify and hold harmless the Released Parties from any and all liabilities, damages, losses, costs, or expenses (including reasonable attorneys' fees) arising out of or in connection with any claims brought by third parties arising from the Participant's participation in activities provided by Skool U! LLC, including but not limited to, the use of any facilities and the use of video and photo as described in section 4.

## 6. Severability

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not be affected or impaired thereby.

#### 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Texas.

#### 8. Acknowledgement

The Participant and Participant's family acknowledge that they have read and understand this Agreement, and they acknowledge that it is a condition of their participation in activities provided by Skool U! LLC.
